PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN FIRST REAL ESTATE INVESTMENT TRUST

The Board of Directors of Bowsprit Capital Corporation Limited (the "**Company**"), the Manager of First Real Estate Investment Trust ("**First REIT**") wishes to announce that 1,135,963 Units have been issued to the Company on 26 July 2013 at an issue price of S\$1.2023 per Unit. These Units were issued to the Company in payment of 70% of the Management Fee comprising the Base Fee and Performance Fee (as defined in the Trust Deed constituting First REIT, ("the **Trust Deed**")) for the period from 1 April 2013 to 30 June 2013. The balance of the Management Fee (as defined in the Trust Deed) of S\$585,329.55 (excluding applicable goods and services tax) was paid in cash.

With the above-mentioned issue of Units, the Company holds an aggregate of 28,233,213 Units, representing 4.00% of the total number of Units in issue of 705,234,148.
