PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN FIRST REAL ESTATE INVESTMENT TRUST

The Board of Directors of Bowsprit Capital Corporation Limited (the "**Company**"), the Manager of First Real Estate Investment Trust ("**First REIT**") wishes to announce that 1,137,212 Units have been issued to the Company on 17 October 2014 at an issue price of S\$ S\$1.2240 per Unit. The balance of the Management Fee (as defined in the Trust Deed) of S\$927,965.72 (excluding applicable goods and services tax) was paid in cash.

With the above-mentioned issue of Units, the Company holds an aggregate of 35,390,480 Units, representing 4.87% of the total number of Units in issue of 727,306,958.
