PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN FIRST REAL ESTATE INVESTMENT TRUST

The Board of Directors of Bowsprit Capital Corporation Limited (the “**Company**”), the Manager of First Real Estate Investment Trust (“**First REIT**”) wishes to announce that 1,270,828 Units have been issued to the Company on 13 October 2015 at an issue price of S\$1.2697 per Unit. These Units were issued to the Company in payment of 65% of the Management Fee comprising the Base Fee and Performance Fee (as defined in the Trust Deed constituting First REIT, (“the **Trust Deed**”)) for the period from 1 July 2015 to 30 September 2015. The balance of the Management Fee (as defined in the Trust Deed) of S\$868,846.08 (excluding applicable goods and services tax) was paid in cash.

With the above-mentioned issue of Units, the Company holds an aggregate of 40,585,833 Units, representing 5.42% of the total number of Units in issue of 749,321,099.
