- (1) The appointed valuers include KJPP Willson dan Rekan in association with Knight Frank ("KJPP W&R"), KJPP Rengganis, Hamid & Rekan in strategic alliance with CBRE ("KJPP RHR"), Colliers in collaboration with KJPP Alberth, Baroto & Partners ("Colliers"), Cushman & Wakefield VHS Pte. Ltd. ("C&W"), Cushman & Wakefield K.K. ("CWKK"), CBRE K.K. ("CBRE KK"), and Colliers International K.K. ("Colliers KK").
- The properties affected by the Restructuring Exercise are valued in Indonesia Rupiah and have been converted to SGD based on the exchange rate of SGD 1 = IDR 11,494.25 while the Japan Properties are valued in Japanese Yen and have been converted to SGD based on the exchange rate of SGD 1 = JPY 98.04, where relevant as at 31 December 2022.

- (4) Siloam Hospitals Manado is valued at IDR457.6 billion, reflecting \$\$39.8 million while Hotel Aryaduta Manado is valued at \$\$37.9 million. The aggregate market value of the Siloam Hospitals Manado & Hotel Aryaduta Manado is therefore \$\$77.7 million.
- (5) Siloam Hospitals Kupang is valued at IDR211.8 billion, reflecting S\$18.4 million while Lippo Plaza Kupang is valued at S\$30.1 million. The aggregate market value of the Siloam Hospitals Kupang & Lippo Plaza Kupang is therefore S\$48.5 million.
- (6) Siloam Hospitals Buton is valued at IDR124.1 billion, reflecting S\$10.8 million while Lippo Plaza Buton is valued at S\$11.7 million. The aggregate market value of the Siloam Hospitals Buton & Lippo Plaza Buton is therefore S\$22.5 million.
