ANNUAL GENERAL MEETING TO BE HELD ON 21 APRIL 2023

1. INTRODUCTION

The board of directors of First REIT Management Limited (the "**Board**"), in its capacity as manager of First Real Estate Investment Trust ("**First REIT**", and as manager of First REIT, the "**Manager**"), refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order"), which sets out the alternative arrangements in respect of, inter alia, general meetings of real estate investment trusts; and
- (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020, 1 October 2020 and 4 February 2022), read together with the FAQs on "The Holding of General Meetings" issued by Singapore Exchange on 23 May 2022 which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation.

2. DATE, TIME AND CONDUCT OF ANNUAL GENERAL MEETING

The Manager is pleased to announce that pursuant to the Order, the annual general meeting ("AGM") will be convened and held by way of electronic means on <u>Friday, 21 April 2023, at 2:30 p.m.</u> (Singapore time).

Representative(s) from the Board of Directors of the Manager will conduct the proceedings of the AGM.

3. NOTICE OF AGM AND PROXY FORM

The Notice of AGM and the proxy form will be sent to holders of units in First REIT ("**Units**", and the holders of Units, "**Unitholders**") solely by electronic means via publication on First REIT's website and the SGX website¹. Printed copies of these documents will <u>not</u> be sent to Unitholders.

4. NO PERSONAL ATTENDANCE AT AGM

As the AGM will be conducted in an electronic format, **Unitholders**, **including CPF and SRS** investors, will not be able to attend the AGM in person.

To facilitate Unitholders' engagement, the Manager will implement real-time remote electronic voting ("live" voting) and real-time electronic communications ("live" Q&A) at the AGM.

5. ALTERNATIVE ARRANGEMENTS FOR PARTICIPATION IN THE AGM

Unitholders, including CPF and SRS Investors, may participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions to the Chairman of the AGM in advance of, or "live" at, the AGM; and/or
- voting at the AGM (i) "live" by the Unitholders themselves or their duly appointed third party proxy(ies) (i.e., persons other than the Chairman of the AGM) ² via electronic means; (ii) "live" by the CPF or SRS investors themselves via electronic means if they are appointed as proxies by their respective CPF Agent Banks or SRS Operators; or (iii) by appointing the Chairman of the AGM as proxy to vote on their behalf at the AGM.

Details of the steps for pre-registration, submission of questions and voting at the AGM by Unitholders, including CPF and SRS investors, are set out in the Appendix to this announcement.

In particular, CPF and SRS investors should note that they (i) may vote "live" via electronic means at the AGM if they are appointed as proxies by their respective CPF Agent Banks or SRS Operators, and should contact their respective CPF Agent Banks or SRS Operators if they have any queries regarding their appointment as proxies; or (ii) may appoint the Chairman of the AGM as proxy to vote on their behalf at the AGM, in which case they should approach their respective CPF Agent Banks or SRS Operators to submit their votes by **5:00 p.m. on Tuesday, 11 April 2023**.

6. PRE-REGISTRATION

Unitholders (including CPF and SRS Investors) who wish to observe and/or listen to the live audio-visual webcast or live audio-only stream of the AGM proceedings must pre-register themselves for the AGM at the pre-registration website at the URL https://www.first-reit.com/ir_agm.html from

For the avoidance of doubt, CPF and SRS Investors will not be able to appoint third party proxy(ies) (i.e., persons other than the Chairman of the AGM) to attend, speak and/or vote at the AGM on their behalf.

Unitholders (other than CPF and SRS investors) who wish to appoint a third party proxy(ies) (i.e., persons other than the Chairman of the AGM) and who submit instruments appointing a third party proxy(ies) by post or via email, do not need to pre-register their proxy(ies) at the pre-registration website, as the Manager will arrange for validly appointed third party proxy(ies) to be pre-registered on such Unitholders' behalf.

- (b) submitting questions to the Chairman of the AGM in advance of, or "live" at, the AGM; and/or
- (c) voting at the AGM (i) "live" via electronic means; or (ii) by appointing a proxy to vote on their behalf at the AGM,

should contact the relevant intermediary through which they hold such Units as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.
